Pinecrest Schools has limited enrollment. Its overhead expenses do not diminish with the Student's departure prior to or during the course of the Year. If the Student's attendance is terminated for any reason, including, but not limited to, transfer to another school, or interruption of education, the unpaid Yearly tuition balance becomes immediately due and payable. There will be no refund of tuition or any other costs if the Student is absent from School for any length of time.

This contract may not be amended or supplemented except by written agreement signed by an authorized representative of Pinecrest Schools. I (We) understand and agree that in the event that I (we) fail to make any tuition payments herein agreed, upon Pinecrest Schools' demand, the entire balance owing shall become immediately due and payable. Pinecrest Schools reserves the right to suspend or disenroll the Student any time that such tuition payments become more than 30 days delinquent.

Pinecrest Schools reserves the right to suspend, dismiss or expel the Student if and when, at Pinecrest Schools' sole discretion, it determines that the School cannot meet the needs of the child, or those of the Student's parents or guardians, or due to unreasonable behavior of the Student or the parents or guardians in contravention of Pinecrest Schools' policies. I (We) further agree that the records pertaining to the Student shall not be released to the parents or guardians until all financial obligations have been met. Pinecrest Schools does not discriminate and each Student is accepted on his or her individual merits. Pinecrest Schools agrees to make every effort to secure personal belongings of its students, but takes no responsibility for cost or replacement thereof.

From time to time, Pinecrest Schools may wish to photograph, videotape or quote students and/or their work in a variety of school-related activities in order that such reproductions may be displayed or published in such school related forums as Pinecrest Schools' yearbooks, newsletters, notices to parents, bulletin boards, and the Pinecrest web site. By signing this contract, you are consenting in advance to such taking and use of such reproductions without Pinecrest Schools having to obtain any further consent from you.
